

- One-stop approval for all permits, operating licenses and incorporation papers;
- Duty-free, tax-free import of raw materials for goods destined for re-export;
- Duty-free introduction of capital goods, consumer goods, components, machinery, equipment and furniture;
- Permission to sell 100% of manufactured, assembled or imported goods into the domestic Nigerian Market;
- When selling into the domestic market, the amount of import duty on goods manufactured in the free zones is calculated on the basis of the value of the raw materials or components used in assembly not the finished product;
- 100% foreign ownership of investments;
- 100% repatriation of capital, profits and dividends;
- Waiver of all import and export licenses;
- Waiver on all expatriate quotas for companies operating in the zones;
- Prohibition of strikes and lockouts;

## How to setup a Company in the CELPLAS Industries FREE ZONE Company (CIFZC) in Nigeria

To set up a company within the free trade zone, a businessman has to take particular steps which are standard for all the free zones of the nation. These steps are given underneath:

- 1. Fill up the application form, which can be downloaded online or collect from the free zone administration office or the headquarters of CELPLAS INDUSTRIES FREE ZONE COMPANY (CIFZC) in Lagos.
- Submit the application form to the Zone Administration Office of CIFZC with appropriate Project Plan / Feasibility Report. The application will be examined within five working days and, by the completion of this period, the application may be approved or may be rejected by the administration.
- 3. If the application is accepted, an Operating License (OPL) will be given to you by CIFZC. After receiving the OPL, the Free Zone Administration explores the location of your site and allocates / reserves space for you.
- 4. Receive a Certificate of Importation from one of the various banks located in the zone, or within Nigeria.
- You may Lease a ready Warehouse or Factory Space and start your Business or you can construct your office or warehouse in the Land allotted to you. You need to submit four copies of full architectural drawings for approval to Zone Management if you are constructing your building or warehouse. You need to ensure that the built-up spaces should not surpass 65% of the leased land. Construction should commence within three months after all formalities and the agreement is executed.
- Move in and start your business. CIFZC has designed the process to be as streamlined and user friendly as possible. If you are employing any foreign nationals and employees then you will have to obtain permissions for them which can be done very easily at the immigration desk offices in the CIFZC Zone.

The above benefits are provided by CIFZC Zone in Sagamu Ogun State, Nigeria and thus it is a very lucrative choice for both domestic and international entrepreneurs.


CIFZC Free zone in Nigeria is significant and a rewarding zone that not only attracts foreign investors but also provides job opportunities for Nigerians.
